Packet Checklist and Requirements

Application Information for any U.S. Service Academy Class of 2024

All required information must be provided to my District Office by **5:00 PM PST on Tuesday, November 26th, 2019.**

Each applicant requesting a nomination must meet basic eligibility requirements set forth by the service academies:

- Must be at least 17 years old, but not have passed their 23rd birthday (25th birthday for the Merchant Marine Academy);
- Must be a U.S. Citizen and legal resident of California;
- Must be unmarried;
- Must not be pregnant and have no legal obligation to provide financial support for children or other dependents;
- Must be qualified to commit to a minimum of five years of active duty service upon graduation from an Academy

APPLICATION PROCESS

My office requires the following materials in order to consider your request for a nomination:

1. Service Academy Nomination Application Form
2. An official transcript from all high schools, junior colleges, or universities you have attended
3. **Three letters of personal recommendation** from your teacher, counselor, coach, or clergy. Your letter of recommendation must be from someone who can describe your achievements and skills but may not be from a family member. Letters do not have to be sealed.
4. A one-page essay describing why you would like to attend a Service Academy
5. Resume outlining your extracurricular activities

6. **Two** recent wallet sized (2 1/2" by 3 1/2") profile head shot photographs
7. Latest SAT/ACT scores sent directly by the College Board. If you indicate code number **0178** on your SAT test and code number **7273** on your ACT test, the College Board will forward the scores directly to Congressman Gomez's office. Please note that copies of your official scores and scores printed on high school transcripts are also acceptable.

Please submit the entire packet all at once. Once your packet has been reviewed and deemed complete, you will receive written confirmation by mail.

To receive a nomination to an Academy, you must have an open admission file at the academy of your choice prior to submitting your packet to Congressman Gomez's office. You must start an admission file at each academy in which you are interested in attending. If you have not done so, the websites provided below will guide you through the process of completing the preliminary application online.
