I am requesting funding for the Rose Hill Courts Phase IIB project in fiscal year 2024. The entity to receive funding for this project is the Housing Authority of the City of Los Angeles located at 2600 Wilshire Blvd, Los Angeles, 90057. The funding would be used for the third phase of the Rose Hill Courts redevelopment and includes 48 units ranging in size from one-bedroom through four-bedroom, a community center and central park.

The project is an appropriate use of taxpayer funds because it is a crucial component of a redevelopment project that will add much needed housing stock to the City of Los Angeles which is experiencing an affordable housing crisis. The project also supports low-income communities by providing social services to Rose Hill Courts residents and providing economic opportunities from construction/post construction activities.

The project has a Federal nexus because the funding provided is for purposes authorized by 42 U.S.C. 5305(a)(2).
